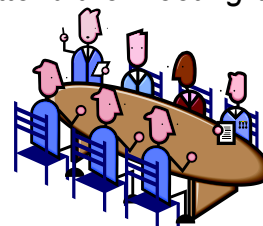
## ANNUAL GENERAL MEETING 2025
