The club is in a great position with steady playing numbers, a fantastic group of volunteers, sound finances and having a great facility to play in.

The biggest project this year was the replacement of the 15 years old green Butterfly tables with new blue Xiom Pro 9 tables. The blue tables certainly change the look in the stadium and we hope you all enjoy playing on them. We would like to thank the Department of Recreation, Sport and Racing and Table Tennis Australia for grants which assisted us in being able to facilitate this project.

Our regular social sessions continue to be well patronised although the numbers can vary. The Tuesday and Friday morning social sessions are popular and average over 40 players a session. The Sunday morning and Monday night social sessions are also becoming busy with all tables being used for the last couple of weeks. I would like to thank Maurice, Bob, Don, Peter, Souyl and Jo who volunteer their time to open up and run these sessions. If anybody else is interested in opening up the stadium for any of our sessions we could use a couple more people to help out.

Our Tuesday night junior program is still running 2 sessions a night and at one stage had over 40 weekly attendees. It is great that we have such high numbers of juniors participating with the limited amount of promotional work that we have been able to do in the local schools. It is interesting to note that over 20 percent of the current competition players have had an association with our junior program as a player or parent. I would like to thank Maurice, Jo, Jay, Peter, Souyi, Jose and Callum who along with me help run the Tuesday night junior program.

The competition numbers have remained pretty stable for the year with Wednesday nights being at capacity. We would like to see an improvement in the Thursday night numbers so that we can run 7 teams in each division but trying to move people over from Wednesday nights or recruiting new players is challenging. This year we had 2 teams compete in the TTSA winter pennant competition. Both teams performed really well and made the finals. We look forward to running a couple of more teams in this competition next year. I would like to thank Bob and Don for opening up the stadium on competition nights. John and Kym for assisting me in coordinating the competition and Matthew for doing the weekly results.

During the year we have been involved in a number of other activities including running tournaments, a 3 day sports exhibition at Colonades, a 20 week Chill-N-Chat program at Aberfoyle Park Community centre, Saturday morning Smash Hit program, School sports competitions, Sporting school's program, School visits and visits by various community groups. It can be surprising how many activities we are involved in throughout the year other

than just the regular 7 weekly sessions that we run. I would like to thank all those that have contributed to us being involved in these other activities.

Financially the club is in a very strong position and despite many rising costs we continue to build up a handy financial buffer. I would like to thank Geoff our Treasurer for all the hard work he puts in to ensure that most years we run at a small financial surplus.

Although we have a large number of volunteers who help run the club one area in which we struggle is having enough people on the executive committee. Currently we only have 5 people as committee members. This is manageable while everything is running smoothly but does put a lot of responsibility on a few people. If you are at all interested in contributing to the running of our fantastic club please consider having a go on the executive committee. Meetings are on the 2<sup>nd</sup> Monday evening of each month.

Southern Table Tennis continued delivering its core junior development activities during 2024/2025. There is much to advise, let's review the reporting period from a junior development perspective;

- Tuesday Night Junior program for the most part of the reporting period, there
  were 30+ juniors in attendance. Those in attendance represented a good cross
  section of primary & secondary schools within the geographical coverage of
  Southern Table Tennis. Certainly, every parent welcomed the ability to use their
  child's Sports Voucher/s to minimize the cost outlayed in participating in the
  program.
- Junior Development Squad under coach Jose, a small squad was formed in June comprising juniors from the Tuesday Night Junior Program. The squad meets each Saturday afternoon. In time, it is hoped the squad will grow with other enthusiastic juniors.
- Smash Hit of the 38 juniors who participated in the program, Southern had 10 juniors from its Tuesday program. Six of the 12 sessions were held at Southern, including the initial grading session and the final trophy presentation session.
- Sporting Schools in the During March 2025, Southern delivered a 4 week program (3 classes of students, 12 sessions in all) at the Lonsdale Heights Primary School. Thanks Denise and Suoyi in assisting program delivery.
- Sports Vouchers In 2025, as an SA Government initiative, primary school students and those in years 7, 8 & 9 each received 2 x \$100 Sports Vouchers for use in a prescribed manner. The majority of Southern returning juniors made use of both their vouchers to cover their participation in both terms 1 & 2/2025.
   Term 3/2025 saw a slight reduction in junior number participating in the Tuesday Night Junior program when student Sports Vouchers had been exhausted.
- Stadium Hire during the reporting period, City of Onkaparinga Base10 and the Brighton Youth Group hired the Southern venue.
- Coaches with accredited coaches Marcel, Jo, Jay, Callum, Suoyi and Jose available to assist deliver the Tuesday Night Junior Program, for the most part, both the 6pm and 7.30pm sessions achieved a good junior to coach ratio.
- Personal Junior Coaching it has been particularly pleasing to have Jose as part of the Southern coaching team. Moreso, Jose has embraced undertaking individual junior coaching sessions and currently coaches several junior players in addition to the squad session on Saturdays. For so long there has only been one coach delivering individual coaching sessions, it is most pleasing to now have Jose sharing that workload.
- City of Onkaparinga Junior Tournament attracted 51 junior players being the second sanctioned junior tournament for 2025. Several Southern juniors participated, including a few from the Tuesday Night program.

- DHS 'Working with Children' clearances I advise that all coaches have a current DHS 'working with children' clearance.
- State Junior Team Southern had good representation at the Nationals in 2025 (host State Victoria) with Marley Jacobs, Callum Roberson, Jamie Hutchinson, Toby Thomas and Gavin Lui named in South Australian teams.

While Southern could be more active in the junior development space, it always gets back to resourcing, both human and financial. I look to the future that may happen one day.

In closing, I thank all those coaches (Marcel Storken, Jo Storken, Suoyi Flieri, Callium Robertson, Jay Storken, Denise Tilter, Jose Navarro) and other persons who assisted me deliver the junior programs and activities in 2024/2025.

# INDEPENDENT AUDITORS REPORT TO THE MEMBERS OF THE SOUTHERN TABLE TENNIS INC.

#### Scope

I have audited the Financial Statements, being a special purpose financial report which comprises a Statement of Receipts and Payments and Notes to the Accounts for the year ended 31 August 2025. The Committee of the entity are responsible for the preparation and presentation of the Financial Statements and they have determined that the accounting policies are appropriate to meet the financial reporting requirements of the Associations Incorporations Act 1985 and are appropriate to meet the needs of the members. The Committee's responsibility also includes establishing and maintaining internal controls where possible relevant to the preparation of the financial statements and that it is free of any material misstatement, whether due to fraud or error.

### Auditor's Responsibility

My responsibility is to express an opinion on the Financial Statements based on my audit. No opinion is expressed as to whether the accounting policies used are appropriate to meet the needs of the members. I have conducted the audit in accordance with Australian Auditing Standards. These standards require that I comply with the relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial statements is free from material misstatement. My audit procedures included examination on a test basis of evidence supporting the amounts shown in the accounts.

The audit opinion expressed in this report has been formed on the above basis.

## Independence

In conducting my audit, I have complied with the independence requirements of the Australian professional accounting bodies.

## **Audit Opinion**

It is not practical for the Club to establish accounting controls over cash collected from all sources prior to receipt. This is consistent to entities similar to this Club and is a result of the limited resources available in accounting procedures.

Accordingly, it is not practical for my examination of these areas to extend beyond amounts recorded in the accounting records of the Club.

Subject to the above, in my opinion, the Financial Statements present fairly, in all material respects the position of the Club as at 31 August 2025 and the results of the operations for the year then ended in accordance with all applicable Australian Accounting Standards and the Association Incorporation Act (SA).
